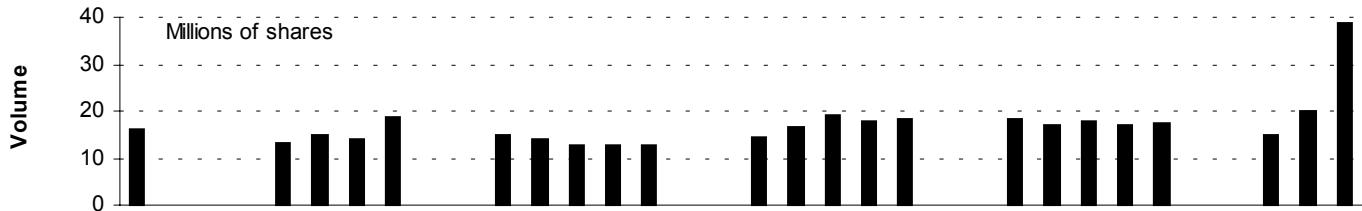
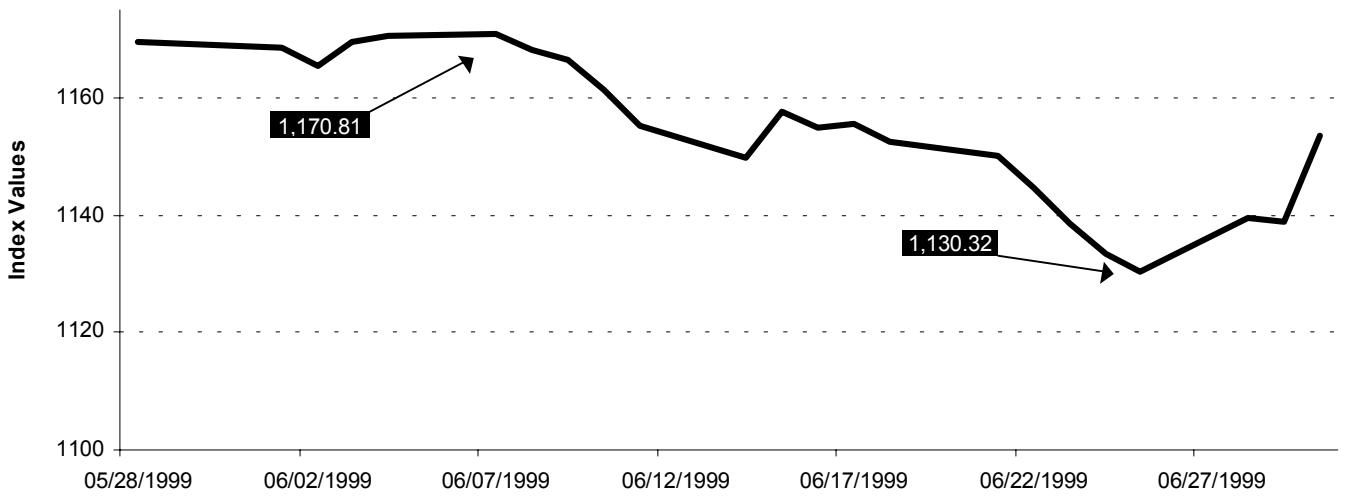
A Monthly Statistical Report on the Real Estate Investment Trust Industry

JULY 1999

At the beginning of 1999, we introduced a new version of the NAREIT Indexes that included a number of new features. These features included daily and real-time index calculations, re-investment of dividends on the ex-dividend date and a change in our source of primary daily market data to Wilshire Associates™. Together, these changes were implemented in response to the growing volume and complexity of information required by today's investment marketplace.

During the first six months of operations, we received many helpful comments and suggestions as well as some constructive criticism. We also obtained valuable first-hand knowledge of the many features of the new systems, as well as insights into how certain aspects of the systems could be improved. For most of the period, the data communications links and operating software worked well. Not surprisingly, however, we also uncovered several operational and data "bugs." Working with Wilshire, we have implemented corresponding data corrections and changes to operational procedures to remedy these problems.

As a result of the comments received over the past six months, plus our own experience, this month's release of the June performance data is accompanied by some additional changes.

Re-Statement of First-Half Returns

During the January-June period, we identified two types of operational and data errors. After receiving recommendations from a number of market participants regarding treatment of these errors, we have re-stated daily returns for the first half of 1999. The re-stated returns primarily affect two days in January, four days in February and one day in April. The performance data in tables 1-3 incorporate these re-stated returns.

The first error, a data transmission error, occurred twice in January and once in April. Owing to problems in the overnight transmission of daily closing share prices, the returns originally calculated for January 11, January 12 and April 29 essentially were double counted in all four REIT index portfolios. In all but one of the occurrences, daily price returns were negative. Thus, the re-stated returns are less negative. Problems related to the overnight transmission of data have since been resolved and should not recur.

The second error occurred during the first four days of February. When the Equity REIT Index portfolio was rebalanced for February, the relative weights of two small companies were incorrectly calculated because of errors in the number of common shares outstanding used to compute the equity market capitalization for these two firms. As a result, one of the companies was significantly over-weighted, and the other company was somewhat under-weighted. These data also have been corrected, and additional procedures to verify reported shares have been instituted. Because both companies were in the Equity REIT Index portfolio, only returns for the Equity and Composite REIT Indexes were affected.

The re-stated returns primarily affect the monthly returns of January and April. Because all but one of the occurrences for which returns were double counted had registered negative returns, the re-stated returns result in an increase in the corresponding monthly and year-to-date returns. For the Equity REIT Index, the January total return was revised from -2.74 percent to -2.09 percent, and the April total return was revised from 9.23 percent to 9.49 percent.

For the Mortgage REIT Index, revisions to the January and April returns were larger than for the Equity REIT Index because the negative returns recorded on the three days for which returns were re-stated were larger in absolute value than the revisions to the Equity REIT returns. For the Hybrid REIT Index, the January return was revised higher, but the April return was revised lower because the Hybrid REIT Index posted a positive return on April 29.

Historical Data

We received a number of questions regarding the daily historical data for 1988-1998. Some have asked for additional information pertaining to the 60 basis point increase in the compound annual total return of the Equity REIT Index when compared with the originally published monthly data. At most, 30 basis points of the total change are attributable to known factors. These factors include the increased compounding frequency of returns from monthly to daily, the shift of the dividend reinvestment date from the payment date to the ex-dividend date, and certain judgmental adjustments made to individual daily returns over the 11-year period. The remaining 30 basis points owes to other factors, including differences in reported dividends and variation in the treatment or timing of corporate events. Until additional information can be provided, we will continue to report historical returns based on the originally published monthly data. In addition, index levels for 1999 now are based on the final monthly index levels published for December 1998.

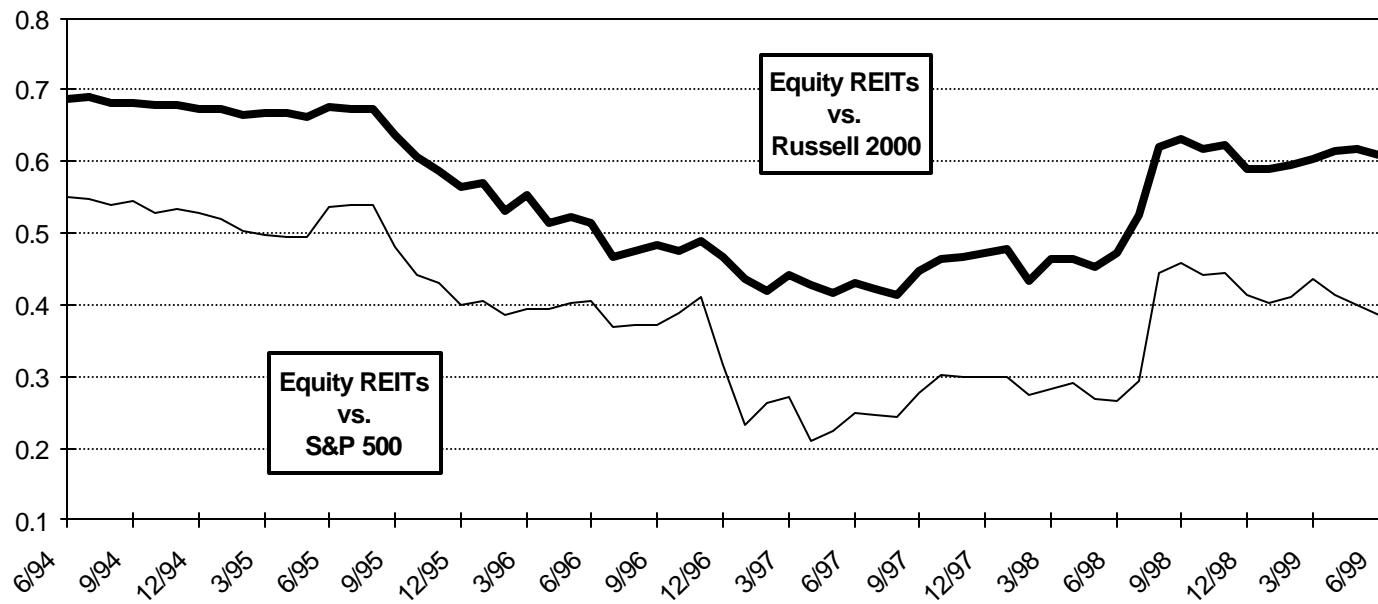

NAREIT Annualized Dividend Yields Less 10 Year Constant Maturity Treasury Yield



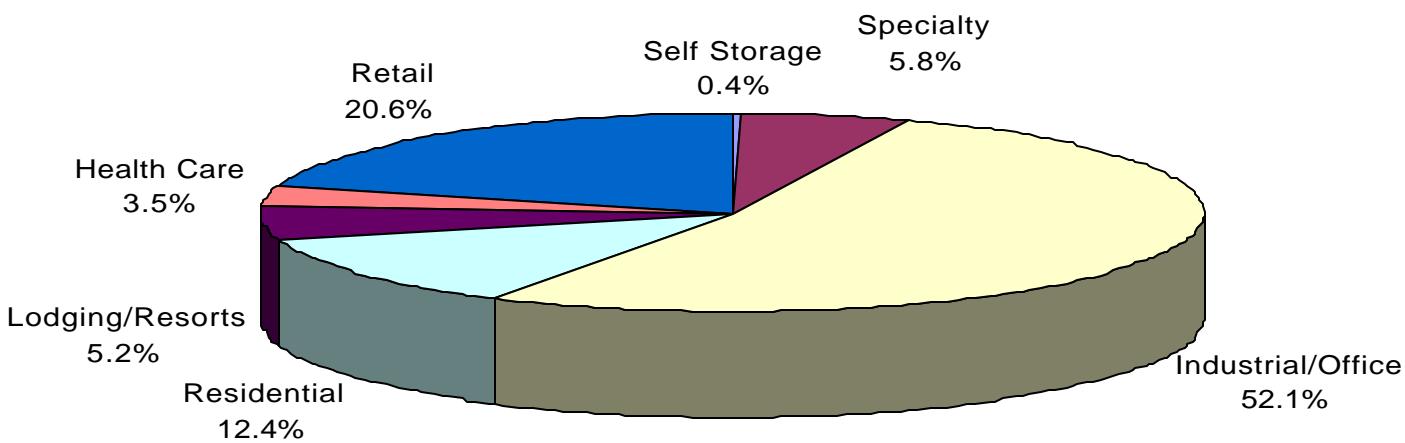

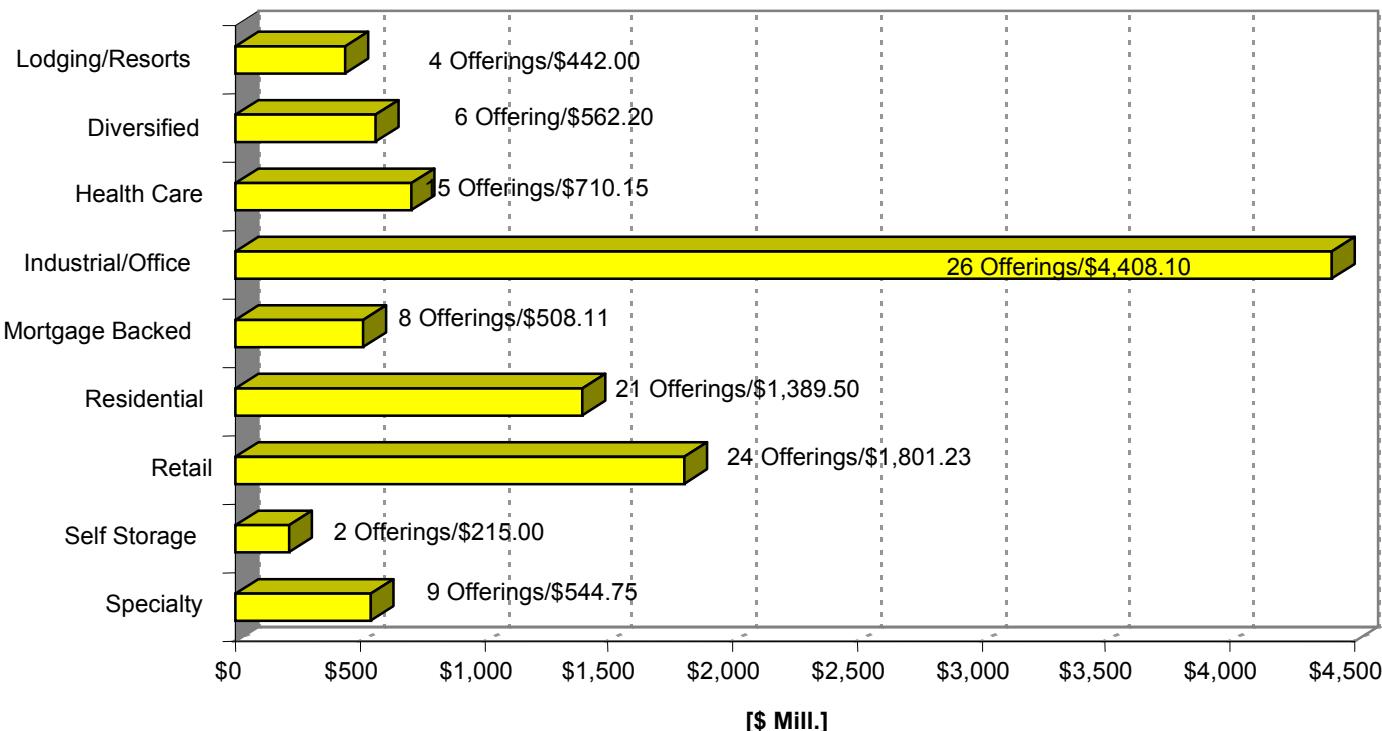

Price/FFO Multiples:	Price on the date indicated divided by the First Call FFO consensus estimates for both 1999 and 2000. Estimates are compiled from First Call on the pricing date.
FFO Growth:	The percentage change between the First Call 1999 FFO estimate and the First Call 2000 FFO estimate. FFO growth is stated in percent.
FFO Estimates:	First Call annual FFO consensus estimates for 1999 and 2000. FFO estimates are displayed in dollars per share.
<u>Dividends:</u>	
Dividend Yield:	The current indicated dividend rate annualized and divided by the current stock price.
Dividend Spread:	The change between the current daily REIT dividend yield and the daily 10-year constant maturity treasury. The dividend spread is stated in basis points.
<u>Total Returns:</u>	
Month:	The total return for the month is calculated by taking the closing price for the current month end adding any dividends with an ex-dividend date in that month and then subtracting the closing price for the previous month. Divide the result by the closing price of the previous month. All total returns are displayed in percent.
Year to Date:	The total return for the calendar year through the latest month end. The returns are calculated with dividends reinvested on a daily basis as of the ex-dividend date.
One Year:	The total return for the previous four quarters.
Two Year:	The annualized total return for the previous eight quarters.
Three Year:	The annualized total return for the previous 12 quarters.
Five Year:	The annualized total return for the previous 20 quarters.
<u>Market Capitalization:</u>	
Equity Market Capitalization:	Price on the date indicated times the number of common shares outstanding. Presented in millions of dollars.
Implied Market Capitalization:	Price on the date indicated times the number of shares outstanding including Operating Partnership Units. Presented in millions of dollars.
<u>Leverage:</u>	
Debt ratio:	A leverage ratio that is calculated by taking the REITs total debt and dividing it by the total market capitalization. Total capitalization includes the sum of both the equity market capitalization and total debt.
<u>Volume:</u>	
Average Share Volume:	The average number of shares traded daily over the past month.
Average Daily \$ Volume:	The average of the daily value of shares traded over the past month. Daily value is computed by multiplying shares traded by the closing price on that date. Data is presented in thousands of dollars.
Relative Liquidity:	Average daily dollar volume divided by equity market capitalization.
